

Dr. Krassimira Daskalova (daskalova@phls.uni-sofia.bg) is Associate Professor in Modern European Cultural History at the Faculty of Philosophy, St. Kliment Ohridski University of Sofia. Her research and teaching interests are in the fields of women's/gender history, history of the book and reading, and South East European cultural history, in comparative historical methods and methodology of history (and women's oral history), the histories of women's movements and feminisms (19th-20th C), and "gendering" history of Central, Eastern and South Eastern Europe. She is author of two monographs on Modern cultural history, editor and co-editor of eleven collective volumes, and many historical essays and articles in Bulgarian, English, German, French, Russian, Romanian, and Bosnian. She has been awarded scholarships by the DAAD, the Indiana University Institute for Advanced Study, the Getty Foundation, the Herzog August Library, the American Council of Learned Societies, etc. She is co-editor of "Aspasia. International Yearbook of Central, Eastern and Southeastern European Women's and Gender History" and of "L'Homme. Europäische Zeitschrift fuer Feministische Geschichtswissenschaft". Krassimira Daskalova served as President of the International Federation for Research in Women's/Gender History from 2005 to 2010.

Associate Prof. Dr. Daniela Koleva (Dept. for History and Theory of Culture, Sofia University St. Kliment Ohridski): Her research and teaching interests are in the field of oral history and biographical research (incl. their potential for the study of women's history), memory, anthropology of socialism and the socialist emancipation of women, Bulgarian historiography. She has been awarded scholarships by the DAAD, Maison des Sciences de l'Homme, Paris, Maison des Sciences de l'Homme et de la Société, Sofia, Wissenschaftskolleg zu Berlin. Her publications include a monograph on the socialist 'normal biography' and a number of articles in international journals and collective volumes in English, German and French.

Nadejda Alexandrova is Assistant-Professor and PhD candidate at the Faculty of Slavic Studies at Sofia University "St. Kliment Ohridski". She has MA in Literary Studies from Sofia University and MA in Gender and Culture from CEU Budapest. As a member of the faculty of Gender Studies Centre at Sofia University she has worked in a number of international research projects in the field of marriage and migration, gender and governance, and citizenship. She has published in international and Bulgarian collective volumes.

Her research and teaching interests are in the field of information resources' management, online retrieval from databases (especially in social sciences), project management, information literacy.
